Per Town Code Section 31.02, Town Council voted at the April Town Council meeting to appoint Richard "Chet" Poland as councilman to fill the vacancy created when Mayor Jackie Robertson was elected February 9<sup>th</sup>. Councilman Poland will hold the seat until a special election can be held to elect a new Council member. The Town has petitioned the court for the special election will be held with the General Election on November 2<sup>nd</sup>. ### THE BLUE LINE

SGT. GEORGE BROZZO

With Mowing Season here, I just want everyone to be aware of their responsibilities as home/property owners in the Town Limits of Boykins. The unofficial mowing season is typically from April 1st to October 31st or when the property is in need of care and upkeep. Please help us all make Boykins look good to our visitors and all its residents. Our ordinance is below for your review and can also be viewed at the Town Office.

§ 50.35 Cleanliness of premises, weeds, foreign growth abatement and prevention of blight of property required.

- (A) It shall be unlawful for any person to deposit or cause to be deposited on any public thoroughfare, lot, or premises in the town, or permit to be deposited upon his premises or any premises contiguous thereto any animal carcass, garbage, rubbish, tree trimmings, litter, bulky wastes from garden or trade, or any other unsightly, injurious or offensive waste of any kind. In addition, it shall be unlawful for any person to place or leave for over ten (10) days any items not designed or intended for exterior use on any open porch, deck, steps or any exterior part of the structure or on the lawn; said items include, but are not limited to, upholstered furniture, appliances, tires and machinery. It shall be unlawful for same to allow, permit or maintain any growth of weeds, grass or unhealthy growths thereon to exceed twelve (12) inches in height.
- (B) The provisions of this ordinance shall not apply to any wooded area, cut over wooded areas of undeveloped land, undeveloped subdivisions, and shall not apply to vacant parcels of property larger than three (3) acres in size located within the town limits.
- (C) When any condition exists on any lot or parcel of land in the town in violation of subsection (A) and (B) herein, it shall be the duty of the mayor and/or supervisor of public works or his designee to serve or cause to be served a notice upon the owner, lessee, occupant, agent or representative of such parcel of land, requiring the owner, lessee, occupant, agent or representative to cut and remove the weeds, grass, unhealthy growths, inoperable machines, tires existing upon such lot or parcel, or portion of parcel within ten (10) days after the service of such notice upon such owner, lessee, occupant, agent, or representative. If the person fails to act to remove the weeds, grass or unhealthy growths or the inoperable machines or tires within the time specified of such notice, the Town shall, through its agents or employees, remove same or have weeds, grass or unhealthy growths cut referred to in such notice on a continuous basis through the balance of the growing season in the calendar year of such notice in order to keep such vegetation at or below the maximum height permitted in section 50-35.

**Did You Know:** As it relates to mowing as described above it is actually a Class 1 Misdemeanor (Virginia State Code) to blow your grass clippings into the roadway or street gutters. If you must cut that way, please follow up by blowing the clippings back off the street. This really causes a hazard to motorcycles, scooters, bicycles and other vehicles. We want the roads to be safe for the motoring public.

# TRASH TRUCK UPGRADE

In December, the town garbage truck got a much needed upgrade, a "grabber". The purchase was made possible with funds granted to the Towns to help mitigate exposure to Covid-19. As you all know, Covid-19 had a huge impact on our little town and protecting our Town Crew from exposure was of the utmost Oimportance. The grabber eliminates the need for two crew members to lift garbage cans, making it possible to adhere to social distancing guidelines, and limits contact to contaminated refuse by physically lifting and emptying cans.





The grabber also makes trash pick-up a much quicker process. Because of its efficiency, our Town Crew was able to pick-up yard debris and bigger household items Monday afternoons. We understand that unexpected change caused some confusion and apologize for any inconvenience the change may have caused. Our Town Crew has resumed yard debris pick-up on Tuesdays.

Remember to have your trash out by 8am on Mondays, and yard debris out by 8am Tuesday. Leaves and pine straw must be in garbage bags. Do not pile leaves and pine straw by the road. It clogs our drains and causes water to pool, which helps breed mosquitos.

# **MOSQUITO CONTROL**

The mosquito population was out of control last year due to the town shop fire destroying our mosquito fog machine. We have purchased a replacement and it was calibrated April 30<sup>th</sup>! The Town Council will review bids for a certified machine operator at the May 11<sup>th</sup> Council Meeting. They will then begin spraying for the mosquitos.

You can help control the mosquito population at home by making sure you empty containers that may collect water.
